COUNCILLOR REPORT

- Tom Grant has resigned from the Executive Committee to open a vacancy for Councillor Neil Johnson from Newell County. Councillor Johnson was appointed to the Executive Committee.
- Reviewed and discussed year end report.
- The following is an excerpt from Tom Grant's report in the Executive Committee minutes: "Member Grant reported that the Vulcan Waste Commission was approved by their Board with the SAEWA Membership Dues Invoice requisition included. Also discussed notice to withdraw from Executive and that he would be continuing to represent the Town of Vulcan on the waste commission just not SAEWA. Tom also mentioned that as part of their last commission meeting a concern was put forward that there is a lack of information being shared with the municipal members on the funding model / tippage fees that will fund the facility. Lastly, reminded that Dick Ellis did advise that Siksika First Nation is interested in receiving more information. (Action Item completed SAEWA Year End Report and several messages sent to Ben Calfrobe as a contact name provided to SAEWA administration by Dick Ellis)"

Constituent Matters:

- Was invited by Councillor Nelson to join her meeting with Queenstown residents to discuss planning and development concerns. Staff helpfully attended the meeting.
- Met Mike Kiemele, Joe Neufeld, Chad Monner, Barry Monner, Mike Peterson onsite to discuss RR 224 access to land from undeveloped road allowance. Agreement reached.
- O Assisted Kevin Love with inquiry into the need for traffic study at new Vulcan rodeo grounds. Anne provided a very helpful response for fellow councillors who might get asked similar questions: "Because the proposal is adjacent to the highway, we are required to refer the application to Alberta Transportation (AT). This referral is required for both rezoning applications and development permit applications. In AT's response, they want a traffic study complete. County's administration is trying to see if AT will accept historical information that we have internally but we haven't received a response yet. We are doing our best to negotiate with AT however it is fairly typical for AT to request a traffic study for any development adjacent to a highway that is beyond a dwelling unit. As soon as I hear from AT I will let you know."
